The Ensuring Safety and Cutting Red Tape Act, 2020, received royal assent on December 9, 2020. The Act will amend the Occupational Health and Safety Act, the Radiation Protection Act and the Workers' Compensation Act. Heroes' Fund for First Responders

The Ensuring Safety and Cutting Red Tape Act, 2020, allows Alberta government to follow through on its commitment to create the Alberta Heroes' Fund for First Responders. This fund honours the sacrifices of first responders who die as a result of performing their duties,



providing a one-time tax-free payment of \$100,000 to eligible families. Eligible first responders include firefighters, police officers, paramedics, sheriffs and provincial corrections officers. Alberta Workers' Compensation Board (WCB) will administer the Heroes' Fund and has begun identifying eligible families and administering payments, which are retroactive to April 1, 2020.

Personal protective equipment



COVID-19 has introduced an increased need for personal protective equipment (PPE), especially respiratory protective equipment. PPE keeps workers safe when other controls aren't sufficient, but it can only be effective if workers use it properly. For this reason, employers must provide thorough and proper training related to its use, care and limitations.

Recent OHS incidents

Below are summaries of selected work-related serious injuries and incidents reported to Alberta OHS. Each incident resulted in a worker being admitted to hospital. Use these incidents as a way to start health and safety conversations in your workplace.

As these incidents are still under investigation, no additional information can be shared

Fall from roof

A worker was leaving a roof and detached their fall protection equipment before reaching the ladder. The worker fell from the roof. *Construction and construction trades*.

Finger crushed

A worker was using a jack to lift a bin when their finger was crushed between the jack and the bin. *Manufacturing*, *packaging* and *processing*.

Hit by object

Workers were performing tree maintenance, using chainsaws to cut branches and stumps, when a branch fell on a worker walking within the felling area. *Municipal government*, education and health.
